CHAPTER 1

INTRODUCTION

1.1 Background of the study

Online learning includes a range of technologies such as the World Wide Web, email, chat, groups and new text, audio and video lectures broadcast over computer networks to impart knowledge. It helps learners learn at their own pace, as per their convenience. There is evidence that traditional face-to-face learning at school is rapidly being replaced by distance learning at home, largely relying on technology, especially in Indonesia (Brinson, 2015: Hoskins, 2013: Seok, 2008). In addition, to support the policies and goals of the Ministry of Education and Culture, different educational levels, from primary to secondary, have used distance learning processes that depend on technologies such as learning online (Hou, Chang, & Sung, 2007). In this situation, teachers and students have to adapt and get used to different online learning platforms.

As explained above, Quipper School is one of the online media learning options available. Quipper provides teachers and students with a ready-to-use web-based learning application. It also supports teachers with virtual storage that allows them to download and save PowerPoint presentations, PDF files, images and videos online.In addition, the storage unit helps teachers store records of teaching and learning activities on the web server; Therefore, they can monitor students' learning without limitations of time and location. What's interesting is that using these widgets in Quipper is completely free, although registration is required. It was launched in January 2014 and has become the most frequently used online learning system today to promote adaptation to online learning. Practically, Quipper school was used at one of the senior high schools in Tasikmalaya Regency in online learning. Every subject uses Quipper School for studying, doing questions, attendance lists, quizzes, etc. Then, Quipper School can be accessed anywhere and anytime because it can be opened via a smartphone, making it easier for teachers and students to carry out an online learning process.

Based on the previous studies, they have shown positive sides about integrating technology. Agustina and Cahyono (2017) conducted a similar study in exploring the perceptions of Indonesian teachers and students on the use of Quipper School. The result shows that the Indonesian EFL teachers used the platform not only for coping with the limited time available for EFL teaching, but also due to the significant value of the platform to support the students' EFL learning. This study further discusses how to use Quipper School in a more significant context, which is the use of Quipper School during Online learning in the Covid-19 era. Their perceptions are essential to figure out the effectiveness and how it impacts the learning processes as they have the actual experience of using Quipper School. Most studies also only focus on perception on one side, whether it's the teacher or student. A recent study by Septinawati et al., (2020) focuses on the students' perceptions toward the implementation of Quipper School as an E-Learning Platform in Teaching English. Meanwhile, a study by Saptani (2016) mainly discussed the teachers' perceptions of the use of Quipper school in teaching English.

However, what differs from previous research in this study is there are negative aspects regarding the interference that occurs when using the application. The previous study only focuses on the teacher perception. Then, the other researcher only focuses on the student's perception. So, I combine both of the perception, there are teacher and students' perception.

1.2 Formulation of the Problem

The research question addressed in the present study is "What are the teacher and students' perceptions towards the use of the Quipper School application during English online learning?"
