**EVALUASI PROGRAM ANTENATAL CARE (ANC) TERPADU DI
PUSKESMAS PURBARATU KOTA TASIKMALAYA 2024**

Permenkes No. 21 tahun 2021 menjelaskan bahwa pelayanan Antenatal Care pada ibu hamil wajib mendapatkan pemeriksaan 10T pada setiap pelayanan Antenatal Care. Tujuan penelitian ini untuk mengevaluasi pelaksanaan program Antenatal Care Terpadu di Puskesmas Purbaratu Kota Tasikmalaya 2024. Jenis penelitian ini adalah kualitatif dengan informan sebanyak 13 orang. Informan utama yaitu Bidan Koordinator KIA dan Bidan Kelurahan, informan kunci yaitu Kepala Puskesmas dan Bidan Pelaksana, dan informan pendukung yaitu kader dan ibu hamil. Teknik Pengumpulan data yaitu dengan wawancara mendalam, telaah dokumen dan observasi nonpartisipatif. Pengolahan dan analisis data dilakukan dengan pengumpulan data, reduksi data, penyajian data, dan penarikan kesimpulan. Hasil penelitian pelaksanaan program ANC Terpadu dengan teori Azrul Azwar yaitu keseluruhan pelaksanaan program dimulai dari perencanaan, pelaksanaan dan pengawasan sudah sesuai dengan apa yang ada di Pedoman Layanan ANC Terpadu dan Permenkes No 21 tahun 2021. Pengembangan program dengan tujuan memperbaiki pelaksanaan kebijakan dan perencanaan program yang akan datang, dari hasil penelitian dapat disimpulkan bahwa dalam P1 masih adanya kendala dalam prosesnya, P2 sudah sesuai dengan pedoman layanan ANC Terpadu dalam pelaksanaan dan pencatatan dan pelaporannya, P3 adanya pengawasan dari internal maupun eksternal. Rendahnya angka cakupan dari K1 dan K4 secara keseluruhan berasal dari ibu hamilnya sendiri.

EVALUATION OF THE INTEGRATED ANTENATAL CARE (ANC) PROGRAM AT PURBARATU PUSKESMAS IN TASIKMALAYA CITY 2024

Permenkes No. 21 of 2021 explains that Antenatal Care services for pregnant women are required to get 10T examination at every Antenatal Care service. The purpose of this study to evaluate the implementation of the Integrated Antenatal Care program at Puskesmas Purbaratu Tasikmalaya City 2024. This type of research is qualitative with 13 informants. The main informants are the MCH Coordinator Midwife and the Village Midwife. Midwife, key informants are the Head of Puskesmas and the Executive Midwife, and supporting informants are cadres and pregnant women. supporting informants are cadres and pregnant women. Data collection techniques are In-depth interviews, document review and non-participatory observation. Data processing and analysis were carried out by data collection, data reduction, presentation of data, and conclusion drawing. The results of the research on the implementation of the results of the research on the implementation of the Integrated ANC program with Azrul Azwar's theory, namely the overall implementation of the program, starting from planning, implementation and supervision. Program implementation starting from planning, implementation and supervision is in accordance with what is in the Integrated ANC Service Guidelines. In the Integrated ANC Service Guidelines and Permenkes No. 21 of 2021. Program development with the aim of improving policy implementation and planning of future programs, from the results of the study it can be concluded that in P1 there are still obstacles in implementing the program. That in P1 there are still obstacles in the process, P2 is in accordance with the Integrated ANC service guidelines in implementation and supervision. Integrated ANC service guidelines in implementation and recording and reporting, P3 there is supervision from internal and external. Low coverage rate of K1 and K4 overall comes from the pregnant women themselves.
