





ABSTRAK

Tujuan Penelitian ini yaitu untuk mengetahui manfaat yang dirasakan oleh guru yang menggunakan telepon seluler sebagai alat untuk membantu ia mengajar. Data diperoleh melalui wawancara dengan partisipasi seorang guru di salah satu Sekolah Menengah Atas di Kabupaten Garut. Analisis tematik digunakan untuk menganalisis data karena analisis tematik fleksibel dan digunakan secara luas dalam penelitian kualitatif oleh Braun dan Clarke (2006). Temuan menunjukkan bahwa terdapat empat tema yang muncul yaitu telepon seluler sebagai sumber informasi, telepon seluler sebagai sumber metode pembelajaran, telepon seluler sebagai media untuk medapatkan motivasi menjadi guru yang lebih baik, dan telepon seluler sebagai media untuk membangun literasi digital.
